In the reference 1st cited, Government have issued orders for sanction of financial assistance under the scheme name of Jagananna Videshi Vidya Deevena to the eligible students of SC/ST/BC/Minority/ EBC including Kapu, who get admitted in any of the top 200 Universities as per the latest QS World Universities ranking on Saturation basis. As per the guidelines of the scheme, the family income shall not exceed Rs.8.00 lakhs per annum.

2. However, it is brought to notice of the Government that few ineligible candidates are obtaining income certificate in the name of parent with less than Rs.8 lakhs, though another family member is a salaried employee with total family income being more than Rs.8 lakhs.

3. In order to avoid misuse of the scheme, a prescribed format for "Family Income Certificate" is appended to this Memo. It is mandatory for taking the Family Income Certificate in the prescribed format from all the applicants of Jagananna Videshi Vidya Deevena Scheme.

4. All the Collectors & District Magistrates in the State are requested to issue instructions to all the concerned authorities to issue the Family Income Certificate in the prescribed format for all the applicants, who are otherwise eligible, under Jagananna Videshi Vidya Deevena Scheme to avoid misuse of the Government funds.
