Matric Scholarships due to bifurcation of the State of A.P.

- i. Not to permit the students of Telangana of those 26 deleted castes from BCs,  
who are pursuing studies in AP, for fresh Registration through AP e.pass from  
2015-16.
  - ii. To enable applications of students upto 2013-14 in respective Principals login  
for verification as usual and to forward to concerned District Officers for  
effective payments duly following the existing process of verification and  
sanction.
  - iii. Enable the applications of students 2014-15 who are local to Andhra Pradesh  
studying in the institutions located in Telangana in the logins of Principals, who  
inturn after verification forward the application to the concerned native  
District Welfare Officers of 13 districts of AP for sanction and release.
  - iv. To enable the applications of students of 2014-15 who are native to Telangana  
and local to Andhra Pradesh and studying in AP in the logins of Principals for  
processing the claims using existing process of verification and sanction.
  - v. To reopen service for both fresh and renewal registration for academic year  
2014-15 duly allowing the category of Telangana (Native) -Andhra Pradesh  
(371D local) - Telangana (Present Study) who are not allowed during 2014-15,  
and,
  - vi. To enable option for uploading GAP certificate/Residence certificate obtained  
by MRO for registration of PMS.
2. The Director of Social Welfare, AP, Hyderabad shall take further action  
accordingly.
